## **ORDER**

- 1. WHEREAS, an RTI application bearing Registration No. OIDBD/R/E/22/00006 dated 05.09.2022 was received from Sh. Raghavendra Dubey seeking information from CPIO, OIDB.
- 2. WHEREAS, a reply on the RTI application was given to the applicant by the CPIO wherein certain information was provided and certain information was not provided to the applicant.
- 3. WHEREAS, the applicant has filed First Appeal bearing registration No. OIDBD/A/E/22/00004, dated 18.10.2022 and stated that the CPIO has denied information against points No.5 & 8 of his RTI application mentioning that the respective files are being searched; denied information against point No. 10 of his RTI application under section 7(9) of the RTI Act, 2005 and denied information against point No.17 of his RTI application under section 8(1)(g) of the Act. The applicant has requested to direct the CPIO to provide requisite information in respect of points No. 5, 8, 10 & 17 of his application on his email ID <a href="mailto:rti.online01011990@gmail.com">rti.online01011990@gmail.com</a>.
- 4. WHEREAS, the then First Appellate Authority (FAA) vide his remarks on the RTI Portal had mentioned that 'Please seek comments from concerned section of OIDB you are also advised to take help of Legal Retainer and accordingly provide the information to the Applicant'.
- 5. WHEREAS, on the basis of the above-mentioned remarks of the then FAA, the CPIO had sent a reply dated 16 March 2023, to the applicant, wherein the information against points No. 5, 8, 10 & 17 of his application was not provided.
- 6. WHEREAS, the First Appeal of the applicant has been examined and it is found that the information sought against points No.5 & 8 of RTI application is available in multiple files yet the information sought cannot solely be denied on this ground. Point No. 10 of the RTI application is of generic nature and not specific/clear as it does not mention the type of goods about which the information is sought. The applicant is therefore, requested to seek the information specifically/clearly. As regards Point No.17 of the RTI application, it has been found that no such information is available as on the date of your RTI application. As such, the CPIO is directed to provide to the RTI applicant, the information sought by the him against points No. 5 & 8 of his RTI application, in the form it is available, including file note and correspondence or any other form, and the concerned section i.e. Administration Section is directed to provide the information sought in these points, in the form it is available, including file note and correspondence or any other form, to the CPIO for providing the same to the RTI applicant.
