**G.S.R. 333.**—In exercise of the powers conferred by section 31 of the Oil Industry (Development) Act, 1974 (47 of 1974), the Central Government hereby makes the following rules further to amend the Oil Industry Development Board Employees' (General Conditions of Service) Rules, 1984, namely:-

1. (1) These rules may be called the Oil Industry Development Board Employees' (General Conditions of Service) Amendments Rules, 2017.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Oil Industry Development Board Employees' (General Conditions of Service) Rules, 1984, for the Schedule, the following Schedule shall be substituted, namely:-
